

## Mother Brunner Catholic School Tuition 2015-2016

Tuition accounts for a little more than half of the revenues needed to cover the cost of educating children at Mother Brunner Catholic School. Here is a quick look at some of the budgeted numbers for the current school year.

- \$6171 per student cost (2014-15 budget).
- \$3833 - average (K-8) tuition received (2014-15 budget).
- \$250 - average state monies (K-8) received (not counting EdChoice Scholarships).
- \$1981 - average amount of subsidy per student given by the parish (2014-15).

\*SMART TUITION is our partner for collecting tuition. Parents are required to sign a registration form granting permission to deduct payments from their accounts. Alternatively, you can set your account up online at [www.enrollwithsmart.com](http://www.enrollwithsmart.com) Payments are due on either the 5<sup>th</sup> or the 20<sup>th</sup> of the month – families choice. SMART TUITION charges a \$40 late charge for each payment not received by the due date. Families already enrolled with SMART TUITION only need to fill out a new enrollment form if you wish to make changes to your current account plan. Full and Two payment tuition payments are paid directly to the Business Office.

*\*EdChoice Scholarships only cover a maximum of \$4250 tuition per student. Our tuition rate for non-parishioners is \$4475 per student. This means the family will be responsible for the balance of tuition at a rate of \$225 per student. This tuition balance is billed to families in July. The scholarship only covers tuition and does not cover any fees charged by our school.*

Additional fees families are responsible for above the tuition cost noted above:

- Registration Fee of \$250 per family due annually at the time of registration.
- Technology fee of \$150 per student due annually on or before July 1st to the Business Office. Late fees of \$35 per student are assessed if not received 10 days after due date.
- Fees families may incur during the school year including:
  - Cafeteria fees – Breakfast and Lunch
  - Extended Learning – Before and After School Care
  - Extracurricular fees – sports and/or clubs etc.
  - Home and School fees
  - Field Trip fees
  - STEP tuition
  - Library Books/ Lost Books and/or materials
