1. \_\_\_\_\_ We (I) anticipate our tuition to be paid in part by the **EdChoice Scholarship or third party**. We (I) understand and agree to pay all tuition payments that the third parties do not cover. Our tuition rate will be calculated utilizing the ten-payment plan. Pay tuition directly to the business office.
2. \_\_\_\_\_ We (I) shall pay using the **Ten payments** plan. I will pay \$ \_\_\_\_\_ per month through the **SMART TUITION** Program. Monthly payments start in **July 2017** and end in **April 2018**. **SMART TUITION** charges a **\$40** late fee per month. Families choose monthly due dates of the 5th or 20th.
3. \_\_\_\_\_ We (I) shall pay using the **Single payment** plan. I will pay \$ \_\_\_\_\_ prior to **July 5, 2017** (found above). A late fee of \$100 will be charged should I be more than 10 days late paying this obligation. Pay tuition directly to the business office.
4. \_\_\_\_\_ We (I) shall pay using the **Two payments** plan. I will pay \$ \_\_\_\_\_ prior to **July 5, 2017** (1/2 of the rate found above) and the second equal payment before **November 5, 2017**. A late fee of \$100 will be charged should I be more than 10 days late in making either payment (\$200 if both are late). Pay tuition directly to the business office.

**By my signature below, I understand and agree to the above selected tuition payment schedule and acknowledge I am responsible for the following fees that are not covered by my student's tuition:**

- **Family Registration Fee of \$250 due at the time of registration.**  
\* Returning Families Registration fee increases \$50 per student after March 6, 2017.
- **Technology fee of \$150 per student due on or before July 1, 2017 to the Business Office.**  
\* Late fee of \$35 per student charged on all Technology fees not paid within 10 days of the due date.
